Notes on 2019-20 finances:

Conference Income:

Conference income is for GAC-MAC-IAH Quebec (payment received May 2021).

IAH International payment:

The 2019 membership dues for IAH-CNC members was \$35,453.86, plus there was a \$100 charge for the wire transfers (two sets), which is included here. Note that there was a refund provided for 2018 dues overpayment of \$3214.74 (not applied to this fiscal statement).

Membership Fees:

Membership fees (\$800) are for our organization to belong to the Canadian Federation of Earth Sciences (CFES), which affords us a reasonable insurance package (\$1640).

Conference Expenses:

Includes covering some expenses for guest speakers or award winners, and minor costs associated with organizing IAH-specific activities.

Scholarship:

Given a great slate of candidates and the fact that no scholarship was given out the previous year, it was decided to award two scholarships this year (\$10,000). Note that we maintain a scholarship fund (\$50,000; within our bank account) and would only draw from this amount if the annual award could not be paid for from general revenue.

Awards:

Toth (student) awards: one winner (\$1000) and one runner-up (\$500).

Website costs:

Total website costs across 2018-19 / 2019-20 were ~ \$27,000. Cost for the new website (across 2018-19 / 2019-20) was ~ \$11,000, which was very close to the initial quote. It costs \$50 / month for our website domain. The remaining costs are not clearly distinguishable (lumped charges by month), but at least several \$1000 are for work on the membership portal and much of the remainder includes unexpected costs associated with security upgrades, especially concerning memberships and member information. The Board does not expect these high expenses to continue. This was 'strategic' spending to overhaul the old website.

Membership Portal Fees:

The membership portal automatically processes memberships and deposits the proceeds in our bank account on a daily basis. The fees include a \$10 monthly charge for this service plus the percentage fees on credit card transactions.

Meeting Expenses:

These include costs for holding teleconference meetings throughout the year and expenses for the Board's annual planning meeting (\$300 in 2019-20).

IAH Admin Expenses:

These were for office supplies (lockable file storage, stamps, envelopes, etc.)

Admin Services:

This covers contracting to Gibson Group Management Inc., who manages our membership payments (managing web portal, but also directly with companies and as liaison with CGS), has been coordinating with the company doing the website work, and performs other admin tasks (e.g., teleconferencing set-up).
